Case Management Checklist: TVAP vs. PRS

TVAP and PRS case managers should discuss division of responsibilities and areas of support based on their location, rapport with the family, and familiarity with local resources. Each case will look different.

TVAP and PRS case managers should also discuss their distinct roles with the minor/family and get the minor's consent to share information and coordinate services.

Legal Services	<ul style="list-style-type: none"> <input type="checkbox"/> Connect to specialized legal services if the minor is pursuing a T visa <input type="checkbox"/> Coordinate with law enforcement if pursuing Continued Presence 	<ul style="list-style-type: none"> <input type="checkbox"/> Provide information about attending court <input type="checkbox"/> Ensure minor has needed documents from ORR <input type="checkbox"/> Connect to low-cost legal resources
Safety & Placement Stability	<ul style="list-style-type: none"> <input type="checkbox"/> Assess for signs of trafficking or exploitation by the sponsor <input type="checkbox"/> Safety plan with the minor around possible re-trafficking concerns <input type="checkbox"/> Notify USCRI with placement stability/safety concerns 	<ul style="list-style-type: none"> <input type="checkbox"/> Assess for safety and stability of placement <input type="checkbox"/> Report child abuse/neglect to CPS and notify ORR with concerns <input type="checkbox"/> Discuss indicators of trafficking or other safety concerns with TVAP provider and coordinate on safety planning
Education	<ul style="list-style-type: none"> <input type="checkbox"/> Address any barriers to the minor attending school <input type="checkbox"/> Support with Federal Student Aid and specialized education options 	<ul style="list-style-type: none"> <input type="checkbox"/> Ensure the minor is enrolled in school and address any barriers <input type="checkbox"/> Request any needed documentation from ORR <input type="checkbox"/> Provide post-18 resources
